Cookies and other similar technologies are tracers that are stored on your device when you visit our website ("cookies"). 1.What kind of cookies does EMobG Services Germany GmbH use?

EMobG Services Germany GmbH uses different types of cookies for the following purposes:

- Absolutely necessary cookies: these cookies are required for the proper functioning of our website. Without these cookies, customers will not be able to use our website.
- Analysis cookies: these cookies allow EMobG Services Germany GmbH to analyse how our customers use our website in order to improve the quality of our website and optimise navigation.
- Advertising cookies: These cookies are used by EMobG Services Germany GmbH and our marketing agencies to measure the effectiveness of our media advertising campaigns.

2. For how long does EMobG Services Germany GmbH store the cookies?

The Europcar Mobility Group uses "persistent" and "session" cookies:

- Permanent cookies are cookies that remain stored on your device between visits until they expire or until you delete them;
- Session cookies are cookies that are temporarily stored on your device and automatically deleted.

3. Is the information collected through cookies transferred outside the EU?

EMobG Services Germany GmbH draws your attention to the fact that information collected through the use of certain cookies may be transferred outside the EU. This can be explained by the fact that some of our service providers maintain servers around the world to ensure a better quality of service.

We recommend that you read the privacy policies of these service providers for information on the rules applicable to the transfer of your data.

4. How long are the cookies stored by Europcar?

EMobG Services Germany GmbH uses "persistent cookies" and "session cookies".

Persistent cookies are cookies that remain stored on your device between your visits until they expire or you request their deletion.

Session cookies are stored temporarily on your device and are automatically deleted when you leave our website. Below is a list of the persistent cookies used by Europcar and the length of time each is stored.
